Costs

Our fees are based on the experience of the person acting for you and are calculated using the London Grade 1 rates bands A to D. Solicitors with over 7 years' experience at Grade A have an hourly rate of £500.00 plus VAT. Solicitors with 1 to 7 years' experience at Grade B have an hourly rate of £300.00 plus VAT. Trainee solicitors, paralegals and other fee earners at Grade D have an hourly rate of £250.00 plus VAT.

The amount of time spent on your case depends upon its complexity and several other factors which include reviewing and preparing documents and attending hearings.

There may be other fees incurred during your case which are known as disbursements which may include Court fees, Agency fees, Expert's fees and Counsel's fees. Whether it is necessary to incur disbursements on your case will depend upon the nature and complexity of your case, the value and the remedies sought.

Possession proceedings are never routine and we adapt our approach to the particular client's needs. However, a relatively straightforward possession action is likely to cost in the region of £10,000 - £15,000 plus VAT and disbursements which are likely to include court fees and counsel's fees.

Our fee includes:

- Taking your instructions and understanding your particular requirements
- Reviewing the documentation
- Undertaking appropriate searches
- Sending a letter before action
- Negotiating with the borrower/borrower's solicitors
- Drafting and issuing proceedings
- Serving the proceedings
- Drafting documents and making applications to court

Straightforward matters usually take up to 3 months from receipt of instructions from you to the issue of an Order for Possession but there are many factors outside our control.

Complex matters may take longer and cost significantly more.
